Approx 1532 responded to the east side parking lot of BJs Whittier Rd where I met and spoke to complainant who was id as:

SUBJECT OWNER/OPERATOR OF 2007 CHRYLSER 300 COLOR BLACK MASS REG 669GV6 INSURANCE COMMERCE.

Complainant states she had just left Wal Mart RT 9 proceed down rt30 and turned into main driveway at Target.

Complainant continued past target and entered the parking lot of BJs.

Complainant states she proceeded to the easterly side parking area and pulled into an unoccupied space which abuts the main driveway /entrance to BJs.

Complainant states she was sitting in her vehicle speaking on her cell phone when an unknown W/M approached her driver's side window (which was up)

This male hit her window with his right fist and began yelling at her.

Complainant states unknown male yelled "You fuckin idiot your not parked right".

This male then allegedly kicked the driver's side door with his foot.

Complainant states she was somewhat fearful about subject's actions and rolled down her window to find out what the problem was.

Complainant states male continued to yell and walked to the rear of her vehicle and took out a small red camera and began taking pictures of her vehicle. This male then walked around the passenger side of complainant's vehicle and began taking pictures of the front of her car; male then walked to passenger side window and continued taking pictures.

Complainant states this male again yelled "Fucking Bitch you didn't park right-you fuckin asshole"

Complainant states as she exited her vehicle to find out the male's problems she observed a male & female with young child walking down the traffic isle watching what was transpiring. This couple also appeared to be afraid of males actions any yelled at complainant not to go near the male in question.

This couple quickly entered their parked M/V and left scene (Parties have not been

Complainant states the yelling male continued to take pictures, he then walked to an unoccupied Grey Honda Civic which was parked 2 spaces over in the same aisle. Honda then backed up and drove past complainant and exited the lot.

Complainant was able to obtain the registration as Mass 644JD5- This vehicle listed to Harold Wolf 65 Delmar Ave Framingham Ma 2010 Grey Honda Civic. 8/17/49

Complainant described subject as: W/M - mid 50s - 508- 5-10' - 180-200 lbs- unkempt hair grey in color, moustache, wearing blue jeans and blue shirt

Complainant states she has never seen male before, but she can identify subject and the vehicle.

Complainant's vehicle suffered minor scuff I / imprint damage to paint under drivers side door lock- Damage appears to be under \$250.00 at this time.

1620 Hrs this officer & Sgt Baker went to suspects address. Suspect's vehicle parked in driveway. Vehicle photoed from street for possible identification purposes.

BJs have no video recording of their lots.

Investigation to continue.

Det Crawford complied a photo array to be presented with victim

8/23/11 ; 0920hrs this officer met victim at her workplace and presented the photo array.

Upon viewing the selected photos victim indicates that although one was extremely similar she could not be positive and she would not make a positive identification from the existing photos. (Photos tagged into evidence)

Victim again states that she can identify the male if she saw him in person.

8/24/11- This officer attempted to contact Mr. Wolf to see if he was willing to be interviewed and/or to present his side of the incident.

4 voice messages were left on his home phone (508-877-5541) requesting he contact this officer

8/25/11- 1500hrs male caller identifying himself as Mr. Wolf left voice mail message on officers cell phone.

Male indicates he was willing to met and speak with this officer at Dunkin Donuts Rt 30 at 1500 hrs and to contact him at 508-561-8452 to arrange to meet.

1528 hrs this officer returned call to above cell number. Male identifying himself as Mr.
